We process personal data collected by the form on the website available at https://fintechpoland.com/raport/how-to-do-fintech-in-poland/ ("Website"). The rules and purposes of processing Users' personal data are detailed below.

1. Definitions

- Administrator data. Personal data administrator is FinTech Poland seated in Warsaw, Migdałowa 1, 02-796 Warsaw, entered into the register of entrepreneurs and the register of associations, other social and professional organizations, foundations and independent public health care facilities kept by the District Court for the Capital City of Warsaw Warsaw in Warsaw, 13th Commercial Division of the National Court Register under KRS number 0000588844, REGON 363095315, NIP: 9512401801 (hereinafter referred to as the Foundation).
- 2) Personal data. This is information about a natural person identified or identifiable by one or more specific factors determining physical, physiological, genetic, mental, economic, cultural or social identity, including device IP, location data, online identifier and information collected via files, cookies and other similar technology.
- 3) **User** any natural person visiting the Website leaving their personal data.

2. Categories of personal data.

Foundation processes the following User's personal data:

- 1) first name,
- 2) last name,
- 3) company,
- 4) position,
- 5) e-mail adress,

3. Basis and purposes for processing.

- 1) The Foundation processes data to:
 - a. in order to provide electronic services in the field of providing Users with newsletters and reports of the Foundation then the legal basis for processing is the necessity of processing to perform the contract (Article 6(1)(b) of the GDPR);
 - in order to analytical and statistical purposes then the legal basis for processing is the legitimate interest of the Administrator (Article 6(1)(f) of the GDPR), consisting in conducting analyzes of Users' activity, as well as their preferences in order to improve the functionalities and services provided;
 - c. in order to possibly establish and pursue claims or defend against claims the legal basis for processing is the legitimate interest of the Foundation (Article 6(1)(f) of the GDPR), consisting in the protection of its rights.

4. The period of personal data processing

The Foundation processes Users' Personal Data for a period depending on the basis and purpose of processing. In general, data is processed for the duration of the service, e.g. sending a newsletter, until the consent is withdrawn or an effective objection to data processing is made in cases where the legal basis for data processing is the legitimate interest of the Administrator.

With the proviso that the period for which the Foundation processes data may be extended if the processing is necessary to establish and pursue any claims or defend against claims, and after that time only if and to the extent required by law.

5. User Rights

- 1) The Foundation does not process special categories of personal data referred to in art. 9 and 10 GDPR.
- 2) The expressed consent may be withdrawn at any time without giving any reason. It is enough for the User to send the appropriate information to the contact e-mail address provided below. Withdrawal of consent does not affect the processing of data before its withdrawal. This means that the withdrawal of consent is effective from the date of its receipt by the Foundation and the introduction of changes in the databases, but does not apply to processing prior to withdrawal of consent.
- 3) In addition, Users have the right to: in relation to personal data processed by the Foundation:
 - a. to object to the processing of data on the basis of a legitimate interest, in connection with the particular situation of the person lodging the objection, and in the event that the data is processed for direct marketing purposes - the right to object at any time,
 - b. access to personal data, obtaining confirmation whether personal data is being processed and to obtain information related to the processing of such data,
 - c. obtain a copy of their personal data and request their transfer to another indicated entity in a commonly used, machine-readable format,
 - d. rectification of personal data when they are incomplete or incorrect,
 - e. delete all or some of the personal data if the legal basis for the processing of such data has been removed (consent has been withdrawn) or if the personal data has been processed unlawfully,
 - f. limiting the processing of personal data for the time necessary to decide on the legitimacy of the request to delete or rectify this data or for the time necessary to establish, pursue or defend claims,
 - g. submit a complaint about the processing of data by the Foundation to the President of the Office for Personal Data Protection,
