Terms and Conditions of the Future Finance Summit Event

§ 1

General provisions

- These Terms and Conditions ("Terms") set out the general rules of participation in the Future Finance Summit event ("Future Finance Summit" or "FFS"), organized by the FinTech Poland Foundation, headquartered in Warsaw at Koszykowa 1, 00-564 Warsaw, registered in the register of associations, other social and professional organizations, foundations, and independent public healthcare institutions of the National Court Register under number KRS: 0000588844, REGON: 363095315, NIP: 9512401801 ("Organizer").
- 2. Individuals with full legal capacity ("Participants") may take part in the Event.

§ 2

Participation Rules

- 1. Participation in FFS is granted to individuals who have registered and received confirmation via the provided email address. The number of participants may be limited.
- 2. Registration takes place online via the registration form at https://futurefinancepoland.com/wfw/.
- 3. Registration constitutes acceptance of these terms and conditions and consent to the processing of personal data.
- 4. The registration form requires the participant to provide their first and last name, email address, the name of the company they represent and their position.
- 5. Participation in FFS is free of charge. Participants are responsible for their own travel and accommodation expenses.
- 6. After completing the registration process, the participant will receive confirmation from the organiser at the email address provided. Only upon receiving this confirmation are Participants entitled to take part in the event.
- 7. Along with the confirmation, the participant will receive a login and password. After logging in, they can select which events they wish to attend.
- 8. The participant acknowledges that the event will be photographed and filmed by the organiser for promotional, informational and documentary purposes. They consent to the free recording and distribution of their image and voice in the form of photos and videos by the organiser, including on the FFS website, social media and promotional materials, without any time or territorial limitations.

§ 3

Organizational matters

- 3. The organiser reserves the right to change the programme, date, duration or venue of the event due to important reasons or reasons beyond the organiser's control. Any changes will be announced on the FFS website and communicated to registered participants via email.
- 4. On the day of the event, participants will receive badges. To collect a badge, Participants are required to present confirmation.
- 5. Participants are obliged to wear their badge visibly throughout the duration of the event.
- 6. Participants must comply with all health and safety regulations, fire protection rules and the rules applicable at the event venue. They must also follow the instructions of the organiser and technical staff.

§ 4

Responsibility

- 1. The organiser is not responsible for any items left behind, lost or stolen during the FFS event.
- 2. The Organiser is not liable for any damage caused by Participants. Participants bear full legal and financial responsibility for any damage caused by their actions or omissions.
- 3. The organiser is not responsible for the participant's inability to attend the event due to reasons attributable to the participant, force majeure, the participant's failure to meet technical requirements, or malfunction of their equipment.
- 4. If the Participant breaches the Terms and Conditions or applicable laws, the Organiser has the right to refuse their participation in the Event or remove them from it.

§ 5

Participant's obligations

The Participant agrees to take part in the Event in accordance with applicable law, the principles of social coexistence, the Terms and Conditions, and the generally accepted norms. In particular, the Participant agrees to refrain from violating the rights of other Participants, the legitimate interests of the Organiser, or the rights of third parties.

§ 6

Personal Data

- 1. The Organiser is the data controller of participants' personal data.
- 2. This personal data is processed in accordance with Articles 6(1)(a), (b), (c) and (f) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR).
- 3. The purpose of processing the data is to enable Participants to take part in FFS and to pursue the Organiser's legitimate interests, including establishing, asserting and defending claims.
- 4. The scope of the processed data includes first name, last name, email address, company, position and technical data (e.g. IP address and web browser), as well as an optional LinkedIn profile.

- 5. Data may be shared with entities cooperating in the organisation of the event.
- 6. Data will be stored for the period necessary to achieve the above purposes and, after the event, for the period required by law or until claims expire, whichever is longer.
- 7. Participants have the right to access, rectify, delete, restrict processing of, transfer, and object to processing of their data.
- 8. The participant may withdraw consent to data processing at any time, without affecting the lawfulness of processing carried out before the withdrawal. Withdrawing consent does not affect the possibility of processing data on other legal grounds.
- 9. Providing personal data is voluntary but necessary to participate in FFS.

§ 7

Final provisions

- 1. Any disputes arising from participation in FFS shall be resolved by the court with jurisdiction over the organiser's registered office.

The organiser will consider the complaint promptly and respond within 30 days at the latest, using the address provided in the complaint.
- 3. The organiser reserves the right to cancel the event for important reasons.
